It may also include an inflation adjustment that can cause the yield to vary substantially from one month to the next.

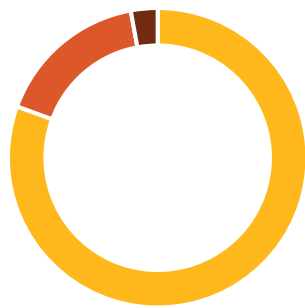
