- *The core components of the quality scoring model are based on quantitative ranking of various metrics obtained from company filings. These scores have three components: Management Expertise (e.g. corporate finance activities).

 Profitability (e.g. assess the reliability and the sustainability of financial performance and Cash flow (e.g. cash flow generation).
- **Companies with a market cap above their respective Developed or Emerging Market Large/Mid Capsize threshold will be designated as Large/Mid-Cap companies in the Northern Trust Global Index. Similarly, companies with a full market capitalization below their category's Large/Mid-Cap Threshold will be designated as a Small Cap company in the Northern Trust Global Index.
